### RESOLUTION OF THE TOWN BOARD OF THE TOWN OF HALIFAX, NORTH CAROLINA

WHEREAS, the Town of Halifax, North Carolina, through the efforts of the Town Board and the citizenry of the Town, has made significant progress in the economic development of the business district therein, and more particularly the town center along both sides of King Street; and

WHEREAS, along with this development, there has been a marked and significant increase in pedestrian traffic along and across both sides of King Street and Pittsylvania Street as well as other streets in the Town of Halifax, to the point of speeding vehicular traffic on said streets presenting a very real danger to pedestrians and property; and

WHEREAS, town officials, citizens, and visitors have noted that vehicles operating on the streets of Halifax quite often ignore caution and common sense and speed upon said streets, even though speed limit signs are erected on said streets, presenting a very real and certain danger to citizens and visitors, especially children and the elderly; and

WHEREAS, after due deliberation and at the suggestion of the Chief Deputy Sheriff of Halifax County, the Town Board has determined that the erection and maintenance of certain other four-way stop signs are desirable and necessary, and in fact essential, for the safety of the citizens of the Town and its visitors and the patrons of the various establishments on King Street; and

WHEREAS, The Town Board has determined that it is in the best interests of the Town and its inhabitants, and would markedly promote their safety, that an appeal be made to the North Carolina Department of Transportation for the erection and maintenance of <u>four-way stop signs</u> (1) at the intersection of <u>King Street and Prussia Street</u>, and (3) a three-way stop sign at the intersection of <u>King Street and Prussia Street</u>, and (3) a three-way stop sign at the intersection of <u>King Street and St. David Street</u> as the Department of Transportation deems necessary for citizen and visitor safety.

#### NOW, THEREFORE, BE IT RESOLVED,

- 1. That the Town Board petition and appeal to the North Carolina Depart of Transportation for the erection and maintenance of the four-way and three-way stop signs at the intersections on King Street described above, and on such other streets of the Town of Halifax as will ensure the safety of citizens and visitors, especially the young and elderly; and
- 2. That the Town Board hereby authorizes and instructs the Mayor and staff of the Town of Halifax to enter into agreements as are necessary to effectuate the erection, maintenance, setting, and posting as aforesaid.

DONE this 20th day of October, 2021, by an affirmative vote of the Board.
